MOAA MEMBER HIGHLIGHT

Ret. Lt. Col. Gene Cushman

If you met Gene Cushman, you would never guess he was 101 years old. Mid 80s maybe, but with his thick silver hair and tall stature, only his birthday of Sept. 24, 1920, confirms his actual age.

Ret. Lt. Col. Gene Cushman 1942-1969, of the U.S. Air Force, served as a pilot and pilot instructor in the early 1940's during World War II.

He began flying when he was attending Baylor School in Chattanooga. An instructor let him fly for \$3 per hour, so he used the \$10 per month his father sent him to get in three hours of flight time. At 20 years old, Cushman headed to San Antonio for preflight training then on to Fort Worth for primary flight training. He flew the PT-19, BT-13, and BT-15, graduating from flight training in 1943. Ranked 2LT, his next assignment was in Waycross, Georgia.

"I wanted to be a fighter pilot," Cushman said. "At Waycross, I was trained in how to fly in formation. They also taught gunnery, because if you're a fighter pilot and can't shoot, you're worthless."

"I flew 56 different airplanes, 42 were military and the others were civilian," he said. "My favorite planes were the P-51 and the P-40. I never had a crash in all my years, never even dented an airplane."

After a 27-year career, Cushman retired from the Air Force and headed back to the U.S. and began his next chapter working in the insurance business. He worked for Protective Life and became a top-level salesman. He retired at age 80 and spent time traveling and playing golf. For more information:

LEGISLATIVE UPDATE

Still No Budget and No NDAA for FY 2022: Here's Why It Matters by Allison Reilly and Brenden McMahon

The last year Congress and the White House enacted the necessary legislation on time to fully fund the government for the upcoming fiscal year was for FY 1997. FY 2022 started like every other year since then, with no budget and the need for a continuing resolution (CR) to ensure the government kept its doors open. Missing the Oct. 1 deadline has tangible consequences: Implementation of new programs is delayed, DoD and other federal agencies cannot modify or discontinue existing programs, and agency leaders begin the new fiscal year with the burden of an unpredictable budget. Even if Congress passes the necessary legislation the damage has already been done. MOAA has long advocated for Congress to address their habitual reliance on continuing resolutions in lieu of passing the annual budget and NDAA on time. Increased party division, political grandstanding, the decline of military experience in Congress, and other environmental factors have only worsened these two decades-long trends.

2023 Could Bring Largest Military Pay Raise in Decades. But Is It Enough? By Mark Belinsky

The Bureau of Labor and Statistics (BLS) unmasked its third-quarter [Employment Cost Index \(ECI\) figures](#) for private-sector wages and salaries Oct. 29, giving a glimpse at the pay raise military members likely will receive at the start of 2023. The 4.6% figure, if it holds, would be the largest raise since a 5% hike in 2002, but will it hold, and even if it does, will it be enough? MOAA closely tracks ECI reports because, by statute, military pay raises are tied to the index unless the administration or Congress intervenes to change the law, as they did by cutting the raise from 2014 to 2016. The military pay raise fell a total of 2.6 percentage points behind ECI those three years. It's tracked with ECI since then, including this year – the 2020 ECI benchmark of 2.7% is part of both the House and Senate versions of the FY 2022 National Defense Authorization Act (NDAA), and the final compromise bill will all but certainly include that figure when it heads to the president's desk for signature. The gap created in 2014-2016 has contributed to some alarming problems. Since that time, uniformed families have experienced soaring spousal unemployment rates, significant shortages of childcare capacity across installations, increased out-of-pocket PCS costs, and a growing demand for food banks and pantries on base. With a looming \$3 trillion deficit, and large infrastructure and social welfare bills on the table, appropriations will be a challenging environment for the next few years. Lawmakers are already discussing flat DoD budgets and will surely look for savings through personnel costs in the future. As DoD looks to protect modernization priorities, some lawmakers are very concerned about junior uniformed families. Vigilantly monitoring military pay and protecting service-earned benefits will require MOAA's continued commitment and focus.

Women Who Serve Pay Too Much for Uniforms by Mark Belinsky

The Military FATIGUES Act of 2021, recently introduced by Sens. Maggie Hassan (D-N.H.) and Joni Ernst (R-Iowa), finally seeks to correct the problem of uniform cost disparity. In some cases, women are paying almost twice as much for the same uniform item as their male counterparts. The Act is straightforward legislation that will require DoD to provide a report to establish consistency across the services and identify how to reduce out-of-pocket costs. MOAA remains committed to improving conditions for those in uniform by supporting legislation like the FATIGUES Act for inclusion into the National Defense Authorization Act (NDAA).

Chapter dues renewals

There are a few left who have yet to renew for the upcoming 2022 calendar year. Time is running short. To keep from forgetting, please go ahead and renew as soon as possible. Courtesy reminders will be sent out to those who have not yet renewed by the day after Thanksgiving. GBC aligns dues renewals to each calendar year.

Please note: If you are not coming due at the end of December, you can still pay ahead of time and acquire years in addition to what you already have. Before the rules change on this, you can renew with GBC for more than one year at a time even before coming due. For example, in December of last year Major Ego selected the 2-year chapter dues option for \$35. He is therefore not coming due at the end of this year. Despite this, Major Ego decided to pay \$50 today for an additional 3-years of chapter dues using his extra COLA money. That means the next time he comes due will be 4 years from now, and he also saved on the reduced cost available to our members using the 2-year and 3-year chapter dues renewal option.

A significant proportion of GBC members do in fact select the multi-year chapter dues payment option from the dropdown menu. As you know, chapter dues are \$20 for a single year. However, you can cut cost on chapter dues by selecting the \$35 for 2 years option, or the \$50 for 3 years option. Thanks to all for supporting our local chapter each year, and those who pay years ahead on chapter dues.
