

OCTOBER MIEETING/SPEAKER

COLONEL (Ret) ROBERT "SCOTT" GRANT

Col. Scott Grant is the former Commander of the 117th Air Refueling Wing, Alabama Air National Guard, Birmingham, Alabama retiring in 2020 after 33 years of service. The 117th trains and equips combat ready aircrews and support personnel to provide worldwide aerial refueling and airlift missions. The 117th was awarded the Strategic Command's "Omaha Trophy" under his command – A first-ever accomplishment for an Air National Guard Wing Colonel Grant received his commission as a Second Lieutenant in the USAF through the Reserve Officer Training Corp in 1987 and graduated from Undergraduate Pilot training in March 1989 at Columbus AFB, MS. He is a career KC-135 Pilot with more than 8,700 flying hours. Colonel Grant began his career a Combat Crew Pilot in the KC-135A. He then became served as an Aircraft Commander in the KC-135R and Instructor pilot in the KC-135A/Q. Before joining the Alabama Air National Guard, Colonel Grant was assigned to the Defense Logistics Agency DPRO Pemco Aeroplex as a flight test pilot flying the KC-135 A/Q/E/R/T aircraft. Since joining the 117th Air Refueling Wing in 1996, Col Grant has served the 106th Air Refueling Squadron as an instructor pilot, evaluator pilot, flight, and squadron commander.

We will also be awarding **State Representative Neil Rafferty** the James Eubanks award for his outstanding contributions to supporting military initiatives in the state of Alabama.

VA Family Caregiver Benefits for 'Legacy' Veterans Extended Through 2025 by Patricia Kime (originally appeared in Militaery.com)

The Department of Veterans Affairs (VA) will extend benefits through 2025 for veterans who joined its family caregiver program under the original eligibility criteria. The extension for the veterans and their caregivers, known as "legacy" participants, will run through Sept. 30, 2025, while the VA continues to review the program, including eligibility criteria that were changed in 2020 as the department prepared to expand the program to veterans from all eras -- a requirement of the 2018 Mission Act. The family caregiver program provides benefits to eligible veterans and caregivers that include support; respite care; health care; and stipends, ranging from roughly \$1,000 to \$3,000, that were meant to reimburse a family member or friend for the care they provide to a veteran in lieu of a home health aide. The program, which originally was established for post-9/11 combat veterans and expanded last year to include those who served before May 1975, is expected to broaden again in October 2022 to include veterans who served between the end of the Vietnam War and Sept. 10, 2001.

<u>VA Accelerates Toxic Exposure Claims, Urges Veterans to Apply Now by Patricia Kime (originally appeared on Military.com)</u>

Veterans who qualify for disability compensation under the recently signed landmark toxic exposures act should begin filing claims. The VA has retroactively designated all health conditions listed in the Promise to Address Comprehensive Toxics, or PACT, Act as presumed to be related to military service effective Aug. 10 -- the date the bill was signed. The law added 23 conditions to a list of presumptive illnesses considered related to burn pits, including certain types of cancer and respiratory illnesses, but they were to be phased in over the next three years, with those who are terminally ill, elderly or survivors having priority and eligible to file immediately. The law also added high blood pressure to the list of illnesses presumed related to Agent Orange, a provision that could affect up to 500,000 Vietnam veterans. Most Vietnam veterans, except for those who are terminally ill; facing financial hardship or homelessness; or were 85 and older, were not eligible to file a claim until October 2026, according to the law. The PACT Act gave the VA the authority to move more expeditiously. The PACT Act provides \$278 billion over the next 10 years to expand VA health care and disability benefits for veterans exposed to a variety of toxins during military service, including burn pits, radiation, herbicides and chemicals.

VA Mishandling of Lejeune Water Claims Denied Veterans \$14 Million in Payments by Patricia Kime (originally appeared on Military.com)

A provision in the Honoring Our PACT Act allows victims to sue the government for injuries related to exposure at Camp Lejeune, North Carolina. The VA mishandled nearly 40% of all disability claims filed for exposure to contaminated water at Camp Lejeune, denying or delaying benefits for more than 21,000 affected veterans. Of 57,500 claims filed since 2017 for illnesses related to water contamination at the base that spanned more than 30 years, the VA denied 17,200 "prematurely" instead of asking for additional information. A total of 1,500 claims were denied for other technical and procedural errors. The mistakes occurred mainly at regional offices, which had a 40% error rate. More than 1 million people were exposed to the chemicals, which can cause various cancers, infertility, miscarriages and death. VA officials in 2017 listed eight specific illnesses as presumed to be related to the water, allowing affected veterans to receive health care and expedited disability compensation. Veterans with diagnoses not included in the list but who served at Lejeune during the time frame also can file claims, although they must prove that their illness was tied to service at the base.
