## LEGISLATIVE UPDATE

### Vets Now Qualify for Toxin-Exposure Screenings House – Originally Appeared on Armed Forces News

All veterans are now eligible for screenings for toxic exposure. The Department of Veterans Affairs (VA) announced the change, which was triggered by the PACT Act that requires delivery of care and benefits to millions who were exposed to toxins and their survivors. The screenings would take about 10 minutes to perform. Veterans would be asked if they believe they were exposed to poisons. Those who say yes would then be asked for more specific details. The list of toxins would include open-air burn pit and airborne hazards, Gulf War-related exposures, Agent Orange, radiation, contaminated water at Camp Lejeune, North Carolina, and other materials and situations. Veterans who need care and merit benefits related to exposures would be directed to the appropriate clinicians and case workers for assistance.

### More Veterans Running for Congress Since 2012 by Leo Shane III originally appeared on Military Times

Nearly 200 Veterans won major-party primaries this year and vied for a seat in Congress in the midterm elections, making this the largest field of candidates with military experience in a decade. The larger pool did not necessarily lead to an increase in the number of Veterans in office, since many hopefuls were in districts that significantly favored their opponent's party. According to research by Veterans Campaign and Military Times, 184 House candidates with military experience won major party primaries and appeared on ballots in November. Another 12 candidates with military experience won U.S. Senate primaries. The 196 candidates represent an increase of about 7% from the 2020 election and the highest total since 2012. But it is still a significant drop-off from the pre-September 11 era, when the number of Veteran candidates – and Veteran election winners – was significantly higher. The field for the 2000 congressional election boasted 218 candidates with military experience in the House alone. In 1997, 197 Veterans served in the House and Senate. The wars in Iraq and Afghanistan led to an increase in the number of young Veterans in America over the last two decades. Of the 194 running this year, 58 (above 30%) began their military service after January 1, 2000. Of the current Veteran candidates, 126 ran as Republicans while 66 ran as Democrats.

### What's Next for MOAA's Budget and NDAA Priorities With Lame-Duck Congress By Jen Goodale

With the lame-duck session for Congress on the horizon, MOAA is closely tracking progress in two areas: full funding of the government and the FY 2023 National Defense Authorization Act (NDAA). It has been 26 years since Congress managed to pass a full budget before October 1, the start of the fiscal year. Another failure to do so means federal operations – to include DoD, the VA, and other programs affecting those in the uniformed services – continue at current spending levels. On September 30, Congress passed a Continuing Resolution (CR) to fund the government through December 16. While passage of a CR is better than a government shutdown, it does not provide funding needed for the annual pay raises, quality health care coverage, and quality-of-life or new programs to enhance the lives of servicemembers and their families. MOAA continues to engage with Congressional staffers, DoD leadership, and other stakeholders to urge lawmakers to pass a budget resolution and the FY 2023 NDAA before the end of the year. Join MOAA's efforts and use the [Legislative Action Center](#) to ask your senators to protect pay and benefits for servicemembers, their families, and survivors.

It's been a long time since I became a surviving spouse, and during that time, I've gone through many stages. None were easy, but all were necessary. No journey out of grief is straight forward. We all handle it differently, and it's how we deal with it that makes a difference.

We must choose to be positive and live or be unhappy the rest of our lives. I chose to be positive, but I also realized that I needed to find a purpose.

When my husband died at the age of 57, I didn't know where to turn or what to do. I became aware that my path forward was to do what I could to make sure no other survivor felt as alone and unprepared as I was. To that end, I joined my local MOAA chapter, took on the job as their surviving spouse liaison, was appointed to the national MOAA's Surviving Spouse Advisory Council, and became active in the Surviving Spouse Virtual Chapter.

I also found not only a mentor but a dear friend because of a chance meeting in 2015. Patricia "Pat" Farnsworth shared her vast knowledge of surviving spouse issues, her wisdom, and her wonderful sense of humor. She encouraged me to do the best I believed I could be — and then pushed for more. Pat died on Oct. 14 at age 86. She was an inspiration to many and a friend to all.

We will never forget our loved ones. We will always miss them. But I have found peace and comfort in my new normal. I hope you find the same
