Col Thomas (Jay) Skinner, ANG.

Topic: Update on Alabama Army National Guard activities and the cooperation programs with European Allies, like Romania.

Col Skinner's Biography

Col. Thomas "Jay" Skinner is a 1990 graduate of the University of Alabama with a B.S. in Commerce and Business Administration with a Major in Real Estate and a 1993 graduate of Cumberland School of Law at Samford University. Col. Skinner began his legal practice with a mid-sized Birmingham firm before founding the Law Offices of Thomas J. Skinner, IV, LLC, with offices in Birmingham and Valley Head, Alabama. Col. Skinner currently serves as the Staff Judge Advocate of the 167th Theater Sustainment Command, Alabama Army National Guard, where he oversees all legal matters for the command. Col. Skinner is also the CBRN liaison officer with the Alabama National Guard's State Partnership Program partner nation of Romania. Col. Skinner's prior assignments include Command Judge Advocate of the 31st CBRN Brigade, Deputy Staff Judge Advocate and Chief of Military Justice of the 167th Theater Sustainment Command, Command Judge Advocate of the 142nd Battlefield Surveillance Brigade, and Senior Defense Counsel for the Alabama Army National Guard. In 2013, Col. Skinner deployed to Southwest Asia where he served in Kuwait and Qatar in support of Operation Enduring Freedom. Col. Skinner recently completed a two-year term as President of the National Guard Association of Alabama, and he is currently attending the U.S. Army War College and is expected to graduate in the Summer of 2024 with a master's degree in strategic studies. Col. Skinner is a resident of Mountain Brook, Alabama, but he also spends a great amount of time at his family's home in Mentone, Alabama.


