### **Major Richard Star Act**

The Major Richard Star Act would end an unjust pay offset faced by tens of thousands of combat-injured veterans by which they lose a dollar of earned DoD retirement pay for every dollar of VA disability compensation. The Act would make those with under 20 years of active service eligible for both disability and retirement benefits. Under current law, only disabled veterans who have served 20 years receive both benefits.

While it's supported by more than three-quarters of Congress, MOAA's work continues to ensure it receives a floor vote and can become a part of the must-pass National Defense Authorization Act. Tell your senators to help combating veterans by 1) Pushing for a floor vote to add the Star Act to the NDAA, and 2) Committing to supporting the bill when it comes to the floor.

### **Competitive Pay for Junior Enlisted**

In the current National Defense Authorization Act, the House has proposed a 4.5% pay raise for military members across the board, except for an additional 15% boost (19.5% total) for E-1 though E-4 and a smaller boost to E-5 pay. The Senate proposes the same 4.5% across the board, but with only a 5.5% increase for E-1 to E03. MOAA hopes to see them meet somewhere in the middle. The government's Quadrennial Review of Military Compensation (QRMC) is underway, but it won't come out until the Summer of 2025, which means the impact of the QRMC probably won't be realized until 2027.

Junior enlisted in the military continue to struggle with food insecurity, housing, and overall quality of life issues. In addition to addressing these needs, the DoD must increase the junior enlisted pay to remain competitive with industries and meet its recruitment and retention goals.

Currently an E-1 with less than two years of service living in Jacksonville, Florida receives \$54,276 annually (including BAH and BAS). Comparing the annual compensation for skilled labor in Jacksonville points to the gap the increase in pay will address.

Automotive Mechanic in Jacksonville, FL: \$63,000
Painter in Jacksonville, FL: \$66,520

I recently read an article in the summer 2024 Harvard Heart Letter entitled, "Take Charge of Your Heart Health". It describes how complex our cardiovascular system is and that there are many moving parts besides our heart. We have over 60,000 blood vessels. 
